Meeting Minutes

Parole Board

- Completed the move and all under one roof.
- SONL-just shy of 6000 registered leveled sex offender.
- Different plans are being looked at to impact number left.
- Auto level for historical cases if certain criteria met for them.
- This plan could auto level 13,000 people to level 1.
- Attempted charges were discussed.
- Clients can contact the Board for any leveling concerns.
- Priority is to those coming in from other states and those being released from prison.
- Some can get relief if not classified. They will get leveled and then apply for relief registration.
- Registrants can apply for relief through the court for C felonies or less.
- Parole Board website will have what they are looking for and info on relief of registration.
- Those who abscond can be auto level to 3 for failing to participate in the leveling process. However, put a note that they can object to score if they come back into compliance.
- Send leveling letter to the last known address of the registrant and level if no response.
- Mirror the Board in the leveling process.
- Relief process for the Board:
 - 2 hearing officers and one board member preside over the hearing.
 - They ask questions about stability and try to determine if the registrant will reoffend.
 - Hearings are on Tues and Thurs.
 - Contact the Board if you'd like to attend a hearing.

- By December Auto level stating once there is approval and how to with current staff.
- Board can run list of who has Sex Offender notified in DOC.
- Discussion of Community Corrections assisting the Board with leveling offenders who are currently on supervision for any type of case.
- This topic will be discussed with OACCD.

OACCD

- Let director know how we want that responsibility of Community Corrections assisting Parole Board with SONL leveling.
- Feel strongly either way let OACCD know.
- Non-static eligible leveling cases were discussed.
- Contact Board if client has leveling paperwork and the Static is not in DOC.
- OACCD web site has been updated.
- This is a short session of legislator.
- County opted out option was discussed for counties due to lack of funding.
- Let board know if someone has been released from an institution and were not leveled prior to release.
- Solution ordinated subcommittee of SOSN for reducing SONL numbers brought up.
- In-house static trainers brought, nut case load turnover rate countered this.
- Upcoming webinar for Static training. Some POs going through it. Additional Static trainings may be relieve pressure.
- SONL Subcommittee will go the Best Practices Subcommittee.
- OMS update Sex Offender scored will be brought over.
- Reminder that risk assessments need to be done within 60 days.

OSP

- New laws for registrants.
- State law to register for international travel 21 days prior.
- Must register new legal name within 10 days.
- This information was sent out to registrants and registering agencies.
- Bench Probation Registrants: OSP gets information that they need to register and could send that to a point of contact in the counties for leveling.
- Registrants are billed \$70 a year if no long on supervision of original sex offence.
- Information on this is on back of registrant form.
- Call or email OSP if a registrant's address is no longer valid.
- Court of appeals case rules that you cannot find a registrant guilty if they had Intent to return to address.
- If homeless, the registrant needs to stay in the same area for 10 days.
- Not sure which county files charges if registrant goes to another county and becomes out of compliance.

- Law Enforcement should not check for compliance of a registrant if they are being supervised, but OSP will email PO if registrant address is out of compliance.
- If a registrant intends to travel to high human traffic area, OSP or the Feds will notify the receiving country. Receiving county will decide if the registrant will enter the country.
- OSP web site has list of international travel of counties that will send home registrants home.
- It is the registrant's responsibility to notify country and Feds 21 days prior to travel. This will also be a state law in 2021.
- Per Oregon law registrants can on register in-person.

Compact

- Staff turnover was discussed.
- This year was a rule making year.
- New rules will not go into effect until April 1, 2020.
- Sex Offender definition was revised.
- Sending state defines what a Sex Offender is.
- Receiving state can impose Sex Offender conditions even if sending does not have them.
- Can send RIs within seven days if offender does not have to register in sending state.
- If available, the Sending State will provide the Receiving State with all risk/need assessments.
- For Reporting Instructions provide narrative and sufficient detail of offence if charges where reduced.
- Travel permit notification, notify though ICOTS if they go to another state on travel permit. Notifications purposes only.

Day 2

Training Sub Committee

- 15 people attended the most recent Sex Offender Supervision Specialist Training.
- This was one of the most experienced class that has participated in a while.
- Added PO Rachel Strickland's tech training given at last SOSN.

- Victim's panel was impactful to the student.
- List of curriculum was given.
- Students' role played of failed polygraph, community notification, and first office visit.
- Static/Stable/Acute training in February in Marion County. Training should be at DPSST and need at least 25 people.
- At next SOSN meeting SONL training and notification process will be covered.
- Planning the next IRR for Stable.
- The IRR will focus on themes people missed on the last one.
- There will have to be a booster training before the IRR. This training could be attached to SOSN meeting. Potentially in July meeting.

Best Practices

- How does the Acute fit in with supervision?
- Polygraph frequency of those who have completed treatment.
- Recommendations in assisting the Board completing SONLs. Complete SONL on those who are being supervised on non-sex crime, but need to be leveled due to a past sex crime.
- Board SONL forms have been approved by the DOJ
- All in favor of recommendation to help with board SONLs.

Brenda will write the recommendation.

Tim from WA Co. cannot be 1st chair. Liz was nominated from 3rd chair and all approved.

Round Table

- Check the Sex Offender Treatment Board website to find out if a provider is suspended.
- Some providers do video chat for treatment.
- If a client has a "no contact" with a PO from the Board ask another county to supervise offender or ask condition to be taken off.
- Max benefit from treatment was discussed.
- Case planning SO Power Point was discussed and PO will take it back to departments to train.
