## SOSN January 28-29, 2020

#### • INTERSTATE COMPACT

- If compact requests are sent without needed documents, contact the Compact office. Agencies have 30 days to respond to requests for contact. Include assessments when sending Compact requests.
- Wait 5 days before sending SOs on ERIs
- Sending state is responsible for victim notification. Box indicating victim notification/victim sensitive will still be in the request page, but don't click it starting April 1, 2020.
- New travel permit rule- Sending state needs to be notified by CAR when travel permits are issued to clients who are returning to the sending state, except for medical and work reasons.
- Compact has seen issues with clients being sent to other states outside of reporting instructions. Do not do this, and contact the Compact office if you see it.
- DOC
  - So OAR changes
    - Email feedback to Denise (OAR changes handed out in the meeting and going to be disseminated electronically). Focus closely on SONL process OARs
    - Denise is hoping to have those changes ready by summer
    - Please send feedback within a month or so of SOSN

### • ROUNDTABLE

- o OATSA
  - Couple new board members
  - Having a training in a couple weeks re: transgender issues
  - OATSA retreat set for the end of May in Hood River. May change to be all day Friday and Saturday
  - Discussed combining SOSN and OATSA- decided it's not effective
- o OYA
  - In the process of upgrading OYA treatment programs
  - SB1008 in effect- presumptive youth offender after January 1, 2020 for any offender not sentenced prior to that. Must hold a waiver hearing to determine if case should be heard in adult court.
  - If you are in need of OYA records, send email to reliefofregistration@oya.state.or.us
- KATIE GOTCH
  - Static/stable training scheduled for March
  - New Acute evaluator workbook is being released soon

• YES, we are still using the Acute

### • PAROLE BOARD

- Amended rule on assessment methodology- if a female client has had no recidivism in the last five years, no other person crimes, no compelling prostitution, and no child abuse, they MAY be auto-leveled to a level 1 offender (see email from Dylan sent to SOSN list-serve)
- Currently considering how to address transgender offenders who are more than 2 years post-op
- Pilot project with community corrections regarding catching up STATIC99R/SONL assessments
  - Several counties are helping with the backlog
  - Cite substantiation for responses on the Static99R, i.e. Police report numbers, page numbers, etc
  - SONL's on female and category B offenders- consider file reviews to save time and cost

# • LAURA SHAVER, MARION COUNTY SO TREATMENT re: UC CURRICULUM

- Still go through full disclosure process and get a pass, however full admission to crime isn't required
- Full disclosure process is mostly covered in one on one sessions
- Some issues with fidelity to UC curriculum- UC covers group sessions but not individual. Huge variance/subjectivity in individual sessions
- UC targets medium and high risk clients. Doesn't address low risk

### • DALE AT OSP

- Registration fees
  - Fees are \$70 per year for people not on supervision for their first second offense. Clients on supervisions for new crimes aren't exceptions- they haven't been getting billed but will now.
  - Client can't pay at the time of registration. They are assessed by OSP and must pay by phone, mail, or in person. One issue is that not all agencies are equipped to accept those payments.
- OSP can notify counties when bench probationers register and need to be leveled, but that information should really be coming from the courts
- Contact Beth Gordon to update SORM regarding client contacts, any other notes

### • COMMITTEE WORK

- Training/case planning
  - Florence SOSN training will address DD clients or resilience. TBD
  - 30 signed up for Static/Stable training, may need a second training
  - Static/Stable IRR

- Will address last year's struggles- sexual preoccupation, sex as coping, and deviant sexual preference
- Will include ideas for ways to ask Stable interview questions in the boosters
- Booster will be in June, IRR will be in July
- Best Practices
  - Continue to use Acute. Will contact Acute creator to address its utility
  - Questions addressed to different county's regarding their policies:
    - Recommendation for RSU requirements?
    - Who supervises Failure to Register clients?
    - Category B SONL processes?
    - Do counties still use PPGs? (mostly not)

## • SONL TRAINING

- SONL forms are available on the SOSN site
- Local Control and Probation cases sentenced after January 1, 2014 are our responsibility, including bench probations
- $\circ$  Where to start:
  - Run list of probation cases, then separate women and juvenile offenders
  - Remove clients who are already leveled and registered
  - Use option 30 then (shift)(F1) to see who has a STATIC99 done versus an LS/CMI
  - Prepare SONL forms for anyone who still needs to be registered prior to their arrival to their office visit (they take time to prepare)
    - Note: some counties don't allow written objectives to clients leveled as a 1
  - Present the SONL forms (assessment, Notice of Rights, objections forms, leveling letter) in person, or send it by mail. Client has 60 days to return NOR/objections
  - Once returned, if no objections, forward forms to OSP
    - If they object, you have 60 days to return response
    - Hearings Officer or Supervisor reviews the assessment and SONL. Must be someone trained on the STATIC99R
  - Chrono the process
  - Update SONL in DOC400
- DOC400 audit tool for SONLs:
  - Option 16, then 4, then 20, then 1. Use designator 'SONL'
- Bonus training See Power Point for Marion County Level 3 offender notification system
