- Quarterly Updates: None
- DV MDT update. Working on issues with DOC visitation with kids.
  - Will be expecting to have contact when released (issue that PO's may run into).
- Last conversation with Patty was regarding DV conditions. She was willing to entertain the idea of using electronic surveillance similar to what is in S.O. Package A. 60/40 on yes, then new elections and turnover so it needs to go back in front of the board.
  - Intimate partner condition may be going away for female DV Offenders
- Reviewed most recent ISU Visiting Administrative review Fact Finding Sheet.
  - Staffed case among group.
  
- **County Engagement:** Possibly send out letters to county directors that have not been engaged. Possible issues may be that smaller counties do not have DV specific caseloads, may be one of two and can't get away. Anyone that knows PO's in other counties should reach out to them about engaging. Denise will bring up in OACCD.

- **LS/CMI & WRNA use:** questions about How Counties use the LS/CMI on Misdemeanor cases: Statute right now states that Mediums and Hi's need to have LS/CMI's done Lows do not.

### **Medford PD- DV Task Force Officers Hull and Garcia, discussing investigation of DV Cases.**

- Task Force since starting has seen a decrease in DV calls for service.
- Most common crimes are ASSA IV and Harassment.
  - Common DV Crimes are ASSA IV, Harassment, Strangulation, Coercion, and Menacing.
- Utilizes the Maryland Lethality assessment
  - 11 questions to make determination. Research backs this model.
  - Program helps police to determine best resources for Victim and Officer gets Victim in Contact with victim resources to keep them safe and away from Offender.
  - 1 in 4 women and 1 in 7 men admit to being victims of DV.
  - If any of the first 3 questions are a yes Tells Officer that it is an automatic Hi danger assessment Police will immediately call Victim advocate.
- September 2015 Jackson County Lethality Assessment Protocol was put in place.
- The role of the DV officer is to conduct in person follow up with victims of Domestic abuse. The contact is made with community works assigned advocate. In person contact is preferred to be made within the first 48 hours of the report.
- Works closely with DA's and community partners.
  - DV sweeps with P&P
  - Jackson County Council of DV....
  - Reserve officers.
  
- **Case Staffing/ Other:**
  - Leslie has access to phone and other communication records at Josephine County Jail. If anyone has someone in jail in JO County she can check for No contact violations.
- **Surveillance camera issues. How do counties handle.**
  - Columbia, denies IRT's if residence is unwilling to take down cameras.
  - Clackamas, cannot tell them to take cameras down can ask them to show monitors.
  - Jackson, issues with not being in court orders. Did have issue with surveillance App. Court granted order saying no surveillance app.
- **DV IRT form discussion:**
  - Streamline IRT's through FVSN, PO to PO staffing.
  - Intimate Partner IRT's must be on DV IRT form.
- Staff IRT's at FVSN especially if they are particularly difficult cases.
