Steve Berger – Proposed schedule for 2017, January in Clackamas; March in Hood River, May in Bend, July in Lincoln County, September in Klamath, November AOC in Eugene.

Parole Board Updates (Patty Cress & Mike Wu):

Recruiting for 5th Board Member.

Regional trainings have started. Welcoming feedback from Counties who have already participated in trainings. In planning phase of Hearings Officer training; possibly ready in March at DPSST in Salem.

Brenda Carney sent out update to sex offender notification. Please review.

Marjuana – Draft policy has been circulated. Originally it was going to be left to local Counties to decide how to manage marijuana use for probationers. Legislature is wanting marijuana to

be treated like a controlled substance. Parole Board needed to review their position and developed a new draft. Executive Board of OACCD assisted in reviewing and giving input on new draft. Okay for those who hold medical marijuana card. To be treated similarly as a prescribed controlled substance and can be used if substantiated. Not to be used for those in treatment or other special circumstances. Call or email Parole Board if needing further clarification. Steve Berger thanked Mike for reaching out to OACCD Exec Team for input.

Waddle case (Probation Case) - DOJ is looking for input from Parole Board and OACCD regarding Special Condition 10. Steve recommended when Parole Board ready to move forward OACCD can help pull a subject matter expert group together to work with Mike Wu.

Liaison - Patty will continue to be point person for OACCD for the Parole Board. Process seems to be working well.

CJC (Mike Schmidt):

First session of using the new definitions of recidivism.

RIC Dashboard version is available. Simplified data to make it more user-friendly. Recidivism dashboard allows you to review data by County. Compares Parole/PPS with Probation. Starts with 1997. Able to sort data by Cohort, Gender, Race, Risk Level (PSC), Crime Category, and Age Group. Uses new definitions which includes misdemeanors.

National Drug Usage Data has not yet been made available. CJC still confirming data; may be available by the end of the year. Data reflects PCS convictions when that is the primary conviction. In Oregon, Meth is still the leading substance for convictions and has increased in past couple of years.

reduced prison usage; questioning why they would continue to fund those Counties. Looks like Oregon CJC will be in a tight budget situation with Justice Reinvestment Initiatives. CJC is scheduling meetings with those identified Counties; ultimately the conversations will be occurring with PPSCC's.

Mike is anticipating there will be a lot of discussion regarding Sentencing Reform.

DPSST (Chris Enquist)

(Handout)

Update on P/P Classes at DPSST. They now have a remediation for firearms during the course of the P/P class; this was not offered previously. P/P classes are filled for those currently on the

calendar. Currently budgeted for one academy per year but have been running more than just the one. As of now, only academy in July is budgeted for next fiscal year.

Curriculum -

Looking for work group regarding Domestic Violence curriculum and one additional for special populations. Looking to schedule two separate work groups with two sessions in January with recommendations ready for curriculum review in March. Steve Berger recommended representation from Family Violence and SOSN could assist with first work group. Steve also recommended Chris connecting with Exec Team to get volunteers identified for second work group.

Legislative Updates (Lara Smith)

Budget – Measure 97 failed; would have put \$6 mil in biennium; now short fall of \$1.7 billion. Trend of lower revenue forecast. Governor considering 12% cuts but will decide what areas she wants to cut from. New Governor Budget coming out Dec. 1st. Ways and Means usually out by March 1st. Community Corrections budget probably not out until July 1st.

Jeremiah reported \$272 mil is current request for Grant in Aid; up a little bit from last forecast.

PCS – Historically OACCD organization has not gotten involved in discussion until a topic has actually become a Bill. Steve Berger advocating to make sure Community Corrections involved in discussions but not taking a position on topic of moving PCS from felony to a misdemeanor. Reviewing to make sure there are no unintended consequences to funding of departments. Currently there are “concepts” but not a formal Bill yet to respond to. We need to make sure funding is there for supervision, services and sanctions.

Jeremiah confirmed these cases represent thousands of cases and millions of dollars. One concept continues them in funding.

Steve thanked Sheriff Myers for being an advocate in supporting Community Corrections and insuring there is funding for supervision, services, and sanctions.

New recommendation from Senator Hayward for short term trans leave expanded to 150 days. Resources vary from county to county.

Bill HB3233 would require Sex Offender treatment to be provided by certified providers; variety of recommendations that could more significantly affect rural counties. SOSN forwarded to OACCD for review. Steve will put it on agenda for January meeting.

ORS regarding Training Reimbursement - OACCD requested to be taken out of ORS. Current concept looks like it appears to have taken out Community Corrections of the ORS so counties will not need to reimburse other county when an employee moves from one county to another.

If anyone is interested in actively participating in Legislative Committee as an OACCD Sub-Committee, please contact Steve Berger. Lara and Betsy will compile a long list of Bills for OACCD to either actively lobby for/against; or just to keep an eye on a particular Bill to see if there are any unintended consequences to Community Corrections funding or services. PCAN (Post-Conviction Advocate Network)

Helen O'Brien, Oregon DOJ; and Marci Nelson, Washington County

Handout is a Quick Reference Guide for what PO's can share with victims. Information included was developed as a result of "victims' rights" or public information. If the victim has opted out of being contacted or kept informed, then the PO's do not need to contact them unless PO feels the victim's life is in danger. Reference Guide vetted through stakeholders and is encouraged to share; some Counties may decide to not share as much detail which is up to that County.

Scott Taylor voiced concern regarding workload that could be generated. Helen referenced that the guide could be used for purposes of knowing what to share or not share if a victim does call the PO. Not necessarily for PO's to generate the phone call.

DV and SO PO's generally have a good understanding about how to work with victims and what information to share. General caseload PO's may not always have the same understanding or experience.

Jeff made a motion to make PCAN an OACCD sub-group. Seconded and approved. Steve will give Helen a charter packet to be filled out. Kiki Parker nominated Steve Berger to be the liaison to the sub-group. It was seconded and approved.

Sex Offender Leveling (Malcolm)

Template being drafted by SOSN for PO's to use to determine leveling system for sex offenders. It will be sent out soon to local counties for review. OSP has a website for notification. Local counties are being asked to remove individual lists on county websites. If a county has predatory offenders who have not yet been leveled, OSP can be contacted to have offender added to their website.

Steve Berger asked if it makes sense to have a date or timeframe for counties to remove their predatory lists from website in order to prevent community members from seeing lists on one county website but not another one. Jeff Wood making recommendation that lists are transferred to OSP no later than February prior to legislative session. Jenna made a motion to have all websites down by February 1st. Seconded and approved.

Static 99 Training Session - SOSN planning to provide one full training and two refresher training sessions.

DOC Updates (Jeremiah Stromberg and Heidi Stewart)

Budget – Timeline for DOC budget is release of Governor's budget. Jeremiah will review impact to Community Corrections. DOC is currently taking snapshots regarding County allocation. Denise Sitler is collecting snapshot information. Every County has a few offenders who have not been assessed. Those "few" add up to 460 who are not included in allocation. Access through Community Corrections that shows who needs assessment. Also impacts the forecast; if population is under reported then it also impacts forecasting in addition to budget building and allocation. May is when allocations will be sent out. The majority are new offenders to supervision or new admissions to DOC who have never had an assessment.

DOC Budget – Coffee Creek over-capacity. For purposes of planning, Heidi is assuming OSPM will not be opening. She is reaching out to local Counties and other States. Marion County interested in contracting work release beds. Lane County looking to contract beds as well. Work Release facilities have to be PREA compliant in order to contract with DOC for beds. Trying to find ways to contract with Sheriff's for local county beds. DOC inmates have access to contact visits with children, curling irons, etc. that they may not have access to in local jails. These types of issues make it more difficult to contract beds. Female offenders may make it difficult for inmates to transfer to local facilities.

Jeremiah met with Stakeholders. DOC will provide monthly list of those inmates who have detainers (currently 2,000 men and 200 women). Detainers and holds keep inmates out of programs including AIP and STTL. In the process of educating Judges and Defense Attorneys on this issue. If Counties want a list, it needs to be determined who the point person(s) will be for each County.

Information requests for Chronos – DOC being requested by Oregon Dept of Justice Office of Cooperative Disability *** to provide copies of chronos as they are investigating disability claims. Heidi requesting a point person from each county to respond to these requests. The requests need to be responded to in a timely manner.

Local Control Manual – Person who used to keep manual current no longer with DOC. Dale Primmer and Denise Sitler working on updating it. Current updated manual will be sent out soon.

Time Study – Scheduled for Fall of 2017 (September – November). Communication with PO's is critical so they can understand importance of the study. Important to coordinate talking points. All Counties will be participating.

Community Corrections Reviews – ORS 423.500 to 423.560 has current language where Director of DOC will review county's compliance on an annual basis. DOC entering a legislative concept that will change it from annually to biennially. Jeremiah working to complete a process that will be meaningful to DOC and local counties and have it be streamlined. Areas of focus: Data Entry, CPC's, OAR Compliance, Biennial Plan Adherence, Continuum of Sanctions, Outcome Measures. Goal is to use technology and particularly use of Dashboards.

Earned Discharge – To date 1291 offenders off supervision to earned discharge (1092 probationers and 199 LC). Only 3% recidivism after first year. In July do another outcome study to see how they are doing compared to other offenders who were not discharged earlier. Overall the population is doing well. Still part of Community Corrections funding; \$4 million in budget without person being on supervision. Earned discharge County gets full rate. Those going to bench probation reimbursement is 90 cents/day vs. the \$11/day reimbursement for earned discharge. Request made to have offenders split out from misdemeanors vs. felonies. Jeremiah said report will break out the two classifications. Jeremiah offering pre-meeting training for newer directors to have a clearer understanding of full budget and incentives.

STTL – Current average is 100/month. One-third drug, 1/3 property, 1/3 statutory; 17% females. 91% no jail sanctions. 95% successfully complete; 3% returned for technical; 2% returned for criminal failure. Very high success rate for program; substantial positive impact to prison population.

Housing approval – DOC having difficulty getting housing approval verification from PO's in a timely manner for STTL inmates. Jeremiah has a report available of County denials. He will send it out to Directors.

Assessment and Case Mgmt Network (Pat S.)

Network focusing on quality control and coaching skills for working with staff on LSCMI assessment and case planning. Recommending to move the inter-rater reliability fidelity focus from LSCMI to case planning for this year. Scott Taylor made a motion to accept the around fidelity to assessment.

Rogue Training Proposal – Strengthen ability of 1st line supervisors to provide feedback and coaching to ensure fidelity and effectively manage our community supervision resources. A few local Counties and DPSST have used this training group in the past with positive experiences. Will train up to 12 people at one time from the combined network. Includes initial planning meeting, 360 Evaluations of supervisor, individual sessions, two-day training and follow-up refresher. Cost is \$10,000 for a cohort of 12 supervisors. OACCD Treasurer gave input that Association could not cover the cost of training of all cohorts in the network. Possibility there could be a combination of County and Association financial support. Steve recommended for Pat to meet with Exec Team to have follow-up discussion regarding financial support. Another suggestion was for local Counties to have their own group of supervisors trained as a cohort and the County would pick up the cost. Pat will join Exec Team meeting on December 15th.

Structured Sanctions Grid (Jeremiah)

Work group formed to update sanctioning grid. Grid had not been amended since 2008 with only minor adjustments at that time. Grid divided into two parts, Incentive and Sanction.

The Administrative Sanctions Grid is in draft form. There will be time to give Jeremiah feedback prior to it becoming a final product. Trying to capture as many non-custody options as possible. Discussion regarding whether or not the grid should include other options besides custody units. Some appreciate having the non-custody suggestions listed on the grid to keep those interventions in the fore-front of PO's options to choose from. Most feedback is to keep on list but possibly put in a separate category.

Multnomah County Dashboards (Scott Taylor)

Scott has been working with DOC to interface electronic information. If Multnomah County has an API then Mult Co. can enter information that would automatically send information to Mult.

and DOC at the same time. Scott has reserved funding for a .5 position with DOC. Scott asking if other Counties want to put in on the other .5 position to have DOC pull out projects related specifically to Community Corrections. Request made for a breakdown of what each County would be responsible for based on allocation rate. Jeremiah will get the breakdown out to Directors prior to December Exec Committee meeting. Jeremiah would ensure that this position would be only used for Community Corrections functions.

FVSN Update (Laura)

Recently completed the last FVSN Academy. Surveys completed showed this was a highly rated Academy. Dr. Wilson provided a training on effects of trauma on brain. Michele Scholl, PO from Washington Co., did a great job providing a training on Stalking.

Medicaid (Kiki)

Offenders have been receiving services through OHP Medicaid dollars. With the potential of changes taking place with Medicaid that the Association needs to contact legislators. Losing those dollars will have negative impact on offenders receiving treatment services in the community. Ken Hales recommended for him to draft a letter on behalf of Association for Steve to sign. Motion seconded and approved.
