- Requested introductions around the table
- Approval of the January minutes postponed to the May meeting in Pendleton

### Kelly Officer – Criminal Justice Commission (CJC) Research Update, 60K vs 30K supervised, Bureau of Justice (BJS) Report

- Funded supervised population of 30,000 (about half Felony Probation, about half Parole or Post Prison Supervision) vs 60,000 per the 2016 BJS Report
- BJS Report, Prisoners 2016, complies prison population to compare incarceration rates across state
- Active Group those being supervised; 29,000 funded; 9,742 misdemeanors not funded
- Inactive Group mostly Post-Prison Supervision
- Abscond Group approximately 18,500

### Aaron Hartman, John Hansen, Chrystal Miller (Program Supervisor) – Klamath County DV Pilot Presentation



- Containment model Punitive; Polygraph driven; Cost
  - Lots of technical violations
  - High jail rate for non-compliance
  - Treatment is expensive lasting as long as two years
- New model skill based, framework of risk, need, responsivity, and use of CBT
  - o Based on cognitive and social learning theory
  - o Skill recitals, YouTube videos, Trauma Informed Approach and Care
  - Complete the LSCMI and WRNA

- o Mental health therapist works on attitude and beliefs
- Victim services supportive of program

#### Nate Roberts and Bruce Douglas – Habilitation Empowerment Accountability Therapy (HEAT)



Powerpoint.pptx

- Therapy program designed for African-American men and women ages 18 29
- Holistic, culturally relevant, responsive, strength-based model
- Emphasizes a positive engagement approach
- Modeled after an Afro-Centric Intervention
- African-Americans were not referred to Drug Courts with the same frequency as their Caucasian-American counterparts
- Non-denominational spirituality is connected to all components: self, family, and community
- Probation Officer in the facility builds relationship prior to release
- Supported by National Association of Drug Court Professionals (NADCP)

#### Katie Roller – Multnomah County Women and Family Service Unit




- Gender specific and trauma informed
- 13 Probation Parole Officers, corrections counselor, two community health specialists, three mental health providers
  - Community health specialists meet with women in jail, meet pre-adjudication, accompany women to DHS hearings, assist with Social Security benefit, assist with housing issues
- Currently serving 523 women
- Child-friendly environment
- Collaborates with Gang Unit

- MacArthur Grant focuses on women of color with mental health and addiction history
  - o Diane Wade House can house 32 justice-involved women, builds a sense of community

Steve Berger, Annette Chrisemer and Saydyie Derosia – Post-Conviction Advocacy Network (PCAN) and Community Corrections Advocacy Network (CCAN) update



- PCAN provides victim centered input
- May provide a practitioner's guide for community partners i.e. District Attorney's Offices
- May provide a Best Practice Guide to corrections

#### Jeremiah Stromberg – Legislative Session Updates; Department of Corrections (DOC) Budgeting

- Covid-19 update; Interstate Compact; Travel Permits
  - See Interstate Compact website for updates
- No state agency budget adjustments occurred during the legislative short session
- If budget had passed two budget notes were attached
  - Continued focus on developing outcomes for community corrections, measures of success, report back in next biennium
  - o Directing department to ask for exception-inflation for community corrections
- New rule includes definition of a case-plan is more than opening it

 $\circ$   $\;$  It is the implementation of at least a goal, a behavioral change, etc

#### Larry Evenson

- March 17 the next phase of Short-Term Transitional Leave (STTL) automation will go into effect
  All sanctions will be entered in the sanction's module in CIS
- Planning for the Evaluation and Community Corrections
  - Will be asking directors for county-specific articles
  - Looking for feature articles
- DOC Leadership Team consisting of the superintendents, director, deputy director, assistant directors, and administrators meet quarterly
  - Guest speaker was Adrien Lawyer, Co-Director and Founder of the Transgender Resource Center of New Mexico
    - Training to be provided for Linn and Douglas counties in the Summer or Fall; email to be sent to other counties regarding participation
- Community Corrections Review (CCR) Work Group to meet for fine-tuning the process
- Judy Bell SOON Manual and Data Entry
  - Encouraged every county to send a representative for training
  - Trainings every month

#### Jim deSully – DPSST (Ethics Training)



- Defining Ethics
- Most common reasons for decertification
  - o Arrests and criminal convictions
  - Off-duty conduct
  - Alcohol/drug use
  - Sexual conduct
  - Misuse of authority
  - Dishonesty/truthfulness
  - o Gross misconduct
  - o Insubordination

- o Performance
- Under investigation
  - Often resign before terminated
- Number one reason Public Safety Professional have their certifications revoked or suspended is dishonesty
  - According to most recent date available, nearly 50% of the police officers decertified between 2012 – 2017 were decertified for dishonesty
- REVISE model for minimizing dishonesty
  - Reminding
  - o Visibility
  - Self-engagement

### Jessica Beach – Pretrial Justice Network

- Portland State University research study Phase I
  - 3% of Criminal Justice Reinvestment Funds
  - Directly correlated the period of time a defendant is incarcerated in jail with the severity of the actual outcome of the case
- Portland State University progressing into Phase II
  - Would like to incorporate all counties in Oregon; at least those with Pre-Trial Programs

### Dylan Arthur, Patty Cress, John Bailey – Parole Board Updates

- Historical Registering Population
  - Those individuals who have been on the registry more than ten years and in the community crime free
  - Oregon State Police running criminal histories
  - Reviewed 100 individuals and have been able to level 73
- Board Members Patty Cress and Greta Lowry reappointed to second terms
- Women, and offenders in the male institution who identify as women, releasing from Coffee Creek will have a safety-planning worksheet

- Parole\_Citation in lieu
- Citations in lieu of warrants
  - o Law Enforcement Officers to issue citations regarding failing to report

- $\circ$  Tool for POs
- Not focused on those who are not community safety concerns
- Request for input in the citation creating process
  - Workgroup to be created

#### Nate Gaoiran – Senate Bill 360 Fee Waiver

- Not required to implement a community service exchange program to work off fees
  - Language is "may" not "shall"

#### Jody Merritt, Jay Scroggins – FAUG (Contact Standards Workgroup)



OACCD FAUG Contact Standards Wo

- "Significant Contact" designator does not work
  - 36 counties have/had different definition of "Significant Contact"
- Workgroup recommendation to remove "Significant Contact" flag from CIS and OMS
- Workgroup recommendation to remove "Significant Contact" language
- Replace with "Measurable Contact"
  - Contacts with offenders that are demonstrative of compliance with OAR and IGA;
    support public safety; aim to provide opportunities to affect behavior change
  - Offender based contacts
    - Office
    - Home
    - Court
    - Day Reporting
    - Employment
    - Field
    - Jail
    - Treatment
- Non-Measurable Contacts
  - Still captured and reported to counties
- Workgroup recommendation to ask counties to identify the total number of contacts required every 30 days by risk level

- When standards are identified ensure they are attainable
- Malcolm McDonald moved to discontinue the "Significant Contact Flag" in CIS and OMS; change terminology from "Significant Contact" to "Measurable Contact" and "Non-measurable Contact"
  - Jodi Merritt seconded
  - Vote taken; none opposed

#### Eric Guyer – Covid 19

- Discussion regarding contact standards for next 60 days
- Should a recommendation be made to local government decision makers?
  - Contacts
  - UA collections
  - Court appearances
- Joint statement from DOC with OACCD to counties
  - Recognizing ability to modify

#### Malcolm McDonald – Sex Offender Supervision Network (SOSN)

- Marion County hosted last training
  - $\circ$  Lots of positives
- Lane County hosting end of April
  - Working with DV clients who have a sex offense
- Denise Peña
  - o Action and Administrative Rule/Sex Offender Provisions Administrative Rule
  - Working on adding Sex Offender Notification Level (SONL) Process for Humanity
    - Provided draft rule to SOSN Executive Group
    - Incorporating feedback

#### Tracey Coffman – Case Management

- New OMS updates have been rolled out
- User Role updates may be addressed by email
- Counties may request changes to text
  - Requests will be reviewed by OCMN
- If FAUG and OCMN not joined suggest at least a delegation of people attend both

#### Denise Peña – FVSN

- Last meeting in February in Jackson County
- Next meeting in Hood River in May
- Planning Committee members for this year identified
- Related to FVSN
  - Tri-County Quality Control Group
  - o Clackamas, Washington and Multnomah Counties
  - Confirm providers comply with SB 81 and OARs
  - o Clackamas created an OAR Checklist for providers to complete
  - Each county has three evaluators
  - Good success rate with providers passing the benchmark

#### **Donovan Dumire – Supportive Housing Justice Network**

- Survival Skills cancelled and email sent to participants
- IGA
  - o Lane County Counsel recommended moving from an IGA to a waiver
  - With Lane County Counsel developed two waivers
    - Eric Geyer to present them to the Executive Team
  - One waiver for the hosting county; the other for participants of the network
  - $\circ$   $\;$  Upon direction from the Executive Team charter will be updated

#### Kristin Casey – Mental Health Supervision Network (MHSN)



OACCD Mental Health Supervision Ne

- Change to Psychiatric Security Review Board (PSRB) Language in DOC/400 regarding "out-count"
- Change to Charter language
  - o Change Severe and Persistent Mental Illness (SPMI) to Serious Mental Illness (SMI)
  - o Elections to be held in Fall; new chair takes over in Winter
- Requesting OACCD approval for a three-day (24 hour) mental health training
  - POs and supervisors
  - Develop proficiency in supervising

- o Trauma Informed; Evidence Based
- Develop consistent state-wide training
- Request for \$1,500 for training supplies
- Motion to approve the language changes and request as presented
  - Malcolm McDonald seconded
  - Vote taken; none opposed

### Jessica Beach – Pretrial Justice Network; additional information

- Last meeting February 27, 2020 in Marion County
- The Pretrial Justice Institute no longer believe risk assessments should be used in pre-trial justice
  - Suggests that because pre-trial assessments incorporate criminal history, such history is racially biased
  - Various organizations including Arnold Ventures, NIC, and National Association of Pretrial Services Agencies (NAPSA) came forward with a different message and continue to support pre-trial assessment
  - Pretrial Justice Network continues to support pretrial assessment
    - "Better than nothing"
    - Not the single tool used to provide recommendations to the court
- Next meeting in May 28, 2020 in Yamhill County

### Nate Gaoiran – Alcohol and Drug Policy Commission

- Completed next Five-Year Strategic Plan
  - Approximately 100-page document
  - Posted on the website
- The Public Affairs Sub-Committee
  - $\circ$   $\;$  Geared toward reviewing legislation  $\;$
- Nate re-elected for another four-year commission

### Steve Berger – CCAN

- Batterer Intervention Program (BIP) Advisory Committee
  - $\circ$   $\,$  On-going review of compliance regarding OARs  $\,$
  - $\circ$   $\;$  Challenges the state is facing regarding definitions to accommodate new legislation  $\;$ 
    - Limited area of expertise Page 10 of 11

• Attorney General has no funding available to contribute

#### Judy Bell – Statewide Office Operations Network (SOON); additional information

- SOON requests to modify name change policy following OIS change
  - Currently an offender's original name at supervision/admission remains their court name through the entirety of their cycle regardless of gender change, name change, marriage, divorce etc
  - Significant change to name
  - $\circ$  With legal documentation
  - Willing to change court name
  - Not for probation cases
    - Offenders must petition the court to have their name changed on that court docket
  - o Notification of name change to victim will be under offender's changed name
- Voting on request postponed until input from victims' advocates and the Department of Justice
