- Fair impartial treatment
- Reasonable protections
- Prompt restitution
- Support Person
- Notify of release from custody
- Notify of hearing
- Can make Victim impact statement at hearings
- More information about JII then general public.
- Consulted on Plea deals.
- Can have JII HIV tested in case of Sex Offenses.

Safety Planning Principles:

- Refer to an advocate
- Don't blame survivor
- Trust that survivor knows best
- Be mindful of Confidentiality
- Know your limits
- Understand the impact of Trauma
- Prepare survivors for possible outcomes, and expect the unexpected.
- Always leave the door open for future interactions.
- As PO's we may not want to be safety planning die to our role.
