SOON/FSN Committee update

Judy Bell

- 2 recommendations:
- 1. When entering sex in DOC, use the offender's legal sex (eventually when a gender field is available in DOC, we will use that for how the client identifies).
- 2. Looking in to allowing AIC's to be able to change their names in DOC to their legal name, instead of the first court name of the cycle. There are concerns that VINE will not update with the name change.

Legislative Updates

Eric Guyer

- Infusion of 26.5-Million-dollar discussion
- SB 497- Misdemeanor DV supervision for Sex Abuse 3 DV, Menacing, and Assault IV-DV
- SB 620- Supervision fees-this bill is moving forward

DOC updates

Jeremiah Stromberg

- HB 2172- All measure 11 crimes, pre-1989 crimes, dangerous offenders and some other crimes
 are not eligible, but the bill does expand who is eligible. Need consistency across counties for
 EDIS eligibility. This is a high focused area over the next few years.
- HB 2002-Bill has been changing but there are still parts that are concerning for community corrections. DOC does not support this bill moving forward.
 - As of last Friday, there was a verbal agreement to remove any and all language that would limit your officer's ability to visit your client at any treatment center or place of public service. This was brought up as an issue in Central Cities in Multnomah County where PO's were dropping in to certain housing units in the old town area. DOC has encouraged them to work directly with Multnomah County on those specific issues and not attempt to legislate it something larger then what the issue really is.
 - They are making changes in the language to EDIS
 - Conditions of Supervision: they are still wanting to push through language that GC02 would be a special condition. They still want all conditions to become part of a checklist and that the courts and PB would check and determine as to which conditions they wish to put in place. Jerimiah continues to argue that this would make all conditions in essence special conditions. We would likely see a disparity between counties. What is lacking in this is that there are no prior assessments of the individuals on which conditions should be checked. There will not be enough information to have judges or the PB pick and choose which conditions should be assigned.
 - Another concern is elimination of supervision fees. DOC will continue to object.
- Governor called on the DOC to close Mill Creek (7/1/21), Shutter Creek (1/1/22), and Warner Creek (7/1/22). Governor has rescinded the closure of Warner Creek.
- The cannabis industry has reached out to DOC about DOC releases being able to work for them. They have been advised to contact the county of release.
- COVID-19 cases have reduced dramatically
- The vast majority of AIC's have been vaccinated
- Round seven of commutations will be completed. No change in eligibility criteria.
- Budget conversations are being held
- CCR will be completed on 7/1/21-6/30/22. The 19-21 CCR will not occur due to COIVD-19.

SB 775 and BM 110 update

Nate Gaorian



- The oversight and accountability subcommittees that been created and they are looking for funding
- Have seen a decrease in the amount of people on supervised probation statewide. This number is now lower then the number of JII on PPS statewide.
- There is an increase in the use of sobering centers statewide
- There is a decrease in PCS citations and police engagement in usable amounts of narcotics statewide. Prior to BM 110 there were about 1,200-1,300 per month and now it is about 300-400 per month statewide.
- Lines for Life information has been disseminated throughout the entire state.
- Data shows that the majority of people that are being cited for PCS are not following up with
 calls to Lines for Life. This committee gets the numbers of calls to Lines for Life every two weeks
 and the numbers are sometimes only in the single digits. Most calls coming in are not from
 people who have been cited.
- OHA recently presented that treatment resources and services are struggling. This may be due
 to the low number of referrals. A well-known treatment facility in the metro area had to shut
 their doors due to this. Right now, it is also hard to recruit CADC counselors at the treatment
 facilities in both rural and metro areas statewide.
- This committee is working on ideas of how to get clientele to engage in treatment services.
- Issues with seizing contraband for GC02 violations. LE is no longer disposing of these items for community corrections. Looking for suggestions and/or recommendations on how to proceed with this topic if SB2002 passes.
