 - Accessing funding is why data is important
 - How do we track the population
- Next steps:

 - Creating webinars/training videos to roll out state-wide
 - Michele Larsen will look into a workgroup for Aid and Assist videos or a resource guide

Gender Responsive Academy

- Committee Members are Christina Stephens, Mandy Gautney, Brie Murphy, Pam Ramsey, and Josie will assist with finding presenters
- Possibility of bringing in presenters virtually to keep low cost
- Location: Washington County Conference Rooms and the Scenario Village
 - End of April/Beginning of May. Dates will not be confirmed until September
 - Can host 60-80 people. The concern is parking-consider doing remote attendance
 - Open to DOC institution counselors and POs first
- 2 full classroom days and a half day of scenarios
 - Previous feedback was that the classroom time was too long
 - Scenarios mis way through to break it up-dependent on availability of scenario village
 - Content: Intermediate fundamentals or advanced track?
 - Can split group 30/30 people for different tracks but the issue is unknown number of those interested. Maybe during sign ups ask-who wants advanced?
- Possibly adding a WRNA booster training with Jason Jones
 - If there is a high need, add the booster to the end?
- Tira Hubbard sent logistics of last academy but no survey results
 - Look through the previous agenda to avoid the exact same training
 - Christina Stephens has those emails
- Do we come up with the ideas now or leave it to the workgroup?
 - Objective for the workgroup to lock down dates before researching presenters
 - What are each county's needs?
 - Women's Mental Health needs, Grief and Trauma, if beginner v advanced tracks, hit on responsivity, women's panel, responsivity in community partners

- WRNA IRR
 - Video and survey are completed.
 - Pick a time to send it out, pending which manual to use. Version 6? Consensus: yes.
 - Use BCP for additional questions rather than Pathways. Focus on Gender Responsive principles
 - Risk/Need factors, strengths, how many WRNAs, collaboration and creating trust, WRNA booster interest
- Pre-adjudication and WRNA use
 - Must be an offender
 - How many people use WRNA without supplemental information? 6
 - With supplementary information: 2-3
 - Working with Emily for pre-adjudication use of WRNA
 - It is unethical to use WRNA for those during trial, not to be used as a pre-release assessment
 - Recommendation to not talk about instant offense and assessment is not validation for that specific population
 - LS/CMI: MHS has given guidance that it could have validity if all questions are asked but ultimately, it should not be used pre-adjudication or use N/A. The only pre-adjudicated tool that is validated is ODARA.
- FSAP-coming at the end of the 5-year program
 - CJC will have specific data on recidivism and where to go from here
- Interest in a Moving On training in Multnomah Co?
- Best practice for Moderate score result is LOW override
 - Once norming is done, this may change score for MED/LOW
- Josie: planting a seed for pregnant/post-partum women best practices for restraints and DOC Doula services
 - Agency interest? DOC has good resources

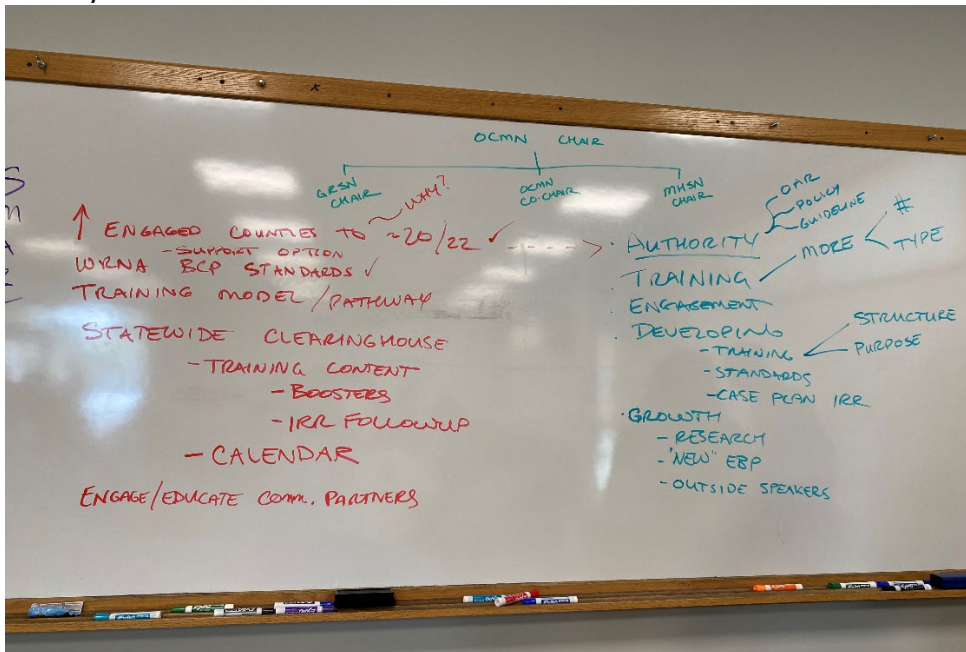

- 92% IRR accuracy reliability
- 86% Technical
- Q23: Not enough information to score or throw it out due to training deficit?
 - Keep question and train to it. Struggling not to double dip activities
- A&D technical errors- being too used to the autoscore
 - Spoon feed it a little more? Q41
 - This is a re-occurring problem. Also the number of “N/A”s being used
- Additional training on antisocial pattern
 - Josephine County has a booster PowerPoint training that they can share
- Upcoming trainings:
 - LSCMI and WRNA
 - September is next Basic P&P academy. Most students are metro area. LSCMI training up in the metro area for them?
 - Suggestion for longer academy? To incorporate more risk assessments
 - LSCMI: Umatilla July 10th- 11th by DOC
 - Finding time and space to do the training is difficult
 - Once academy dates are set, we can set out times around that. Generally Spring and Fall are academy blocks
 - Commit every February and August? Easier to plan
 - Washington County has space, no trainers. DPSST has space: Maria Randall can help train September 23-24. Possibly Jessica Harrison
 - WRNA: Josephine County
 - 3 Jackson County attendees
- Jeff Hanson:
 - Working at NIT with a focus on Community/Corrections technical assistance (academy, trauma informed care, etc.); can help start initiatives for national audiences
 - Anyone can request technical assistance with director approval
 - When NIT does trainings, they pay for it all: PIO, trauma informed case management for institutions and community resources. They are looking for pilot agencies. Will be ready around late 2025-2026
 - 18-24 year old training is a go. 2025: Jeff will create a workgroup to train and train trainers
 - Looking to build true measure to build buy in for trainings
 - Building Gender Responsive 101 training. Built for agencies with little experience in this
 - Revamping NIC publications
 - Safety Matter curriculum for institutions in 2025
 - Focus on Master trainers rather than Train the Trainers
 - His perspective on the work Oregon does: the state is advances in many places but there are some others that have lapped us. What can we learn from it?
 - The more perspective from outside agencies and national levels, the more rewarding and easier it is to do the work
