- Douglas Co shared their procedure for victim contact works with treatment and schedules meeting with victim
- Washington Co 12 weeks of treatment and passed polygraph
- Union Co so many weeks in treatment and has offender create a safety plan prior to victim contact
- Clackamas Co has their victim advocate work with the victim as well, prior to allowing contact
- Update Charter
 - Names in Charter
- DV Standard Conditions
 - Develop a more standard guideline of conditions and expectations so that all counties can be consistent with one another i.e. IRT requirements
 - Electronic Search Condition
 - Must disclose relationships to PO and no offensive contact with any intimate partners. Must disclose DV history to partners.
 - Require BIP successful completion
 - Polygraph per PO
 - Probationer must provide proof of compliance with all programs and follow all deadlines per PO
