Parole Board Updates

- No new updates currently
- Discussed DV Designator and if/what our agencies use this for

Scott Hyde OACCD Liaison

- Working with DOC and Legislation towards the 1145 work group to stabilize funding process.
 - Looking at requirements regarding victim contact
 - Guidelines around allowing it, DVTX, behavior change, overall safety.
 - Wants FVSN to help develop plan for allowing victim contact.
 - Cost for this best practice plan
 - Will be used to develop plan for department funding from the state.
 - Need overall idea of how much general DV supervision will cost the department.
- Developing new sanctioning grid for HB4002 PCS Cases regarding discharge
 - Looking at total revision as well
- Develop best practice for lethality assessment.
 - Used at several points throughout the criminal justice field.
 - Where could the lethality assessment be used in Community Corrections?
 - Is there one that should be used in Community Corrections or by LE at instant offense.

Training

- DV and Strangulation Told Through the Case of Mitchell Bye and Lucy Pepper
 - DV relationship where Lucy was the victim.
 - Using a Strangulation Questionnaire when on scene
 - Use of Pretexting calls
 - Lethality of Strangulation and lethal form of power and control
 - Importance of Strangulation victims to go to hospital for scans.
 - Using contrast on photos of victims
- Peer Support and Acute Stress Adaptive Protocol
 - Changing culture and understanding it
 - Post Traumatic Stress Injury rather than Post Traumatic Stress Disorder
 - Can be healed not fixed.
 - Peer Support Teams are protected under ORS 181A.835
 - Alpha Stim – assists with Bilateral Stimulation
 - EMDR helpful for PTSI
 - Replicates REM sleep

FVSN Initiatives Discussion

- DV Designator
 - Most counties, front staff enter it but if not, POs have been doing it.
 - Used for tracking DV Offenders
 - When Offender Expires, DV Designator will fall off.
 - If DV case expires but Offender is on supervision still on another case, make sure to drop the designator.
 - Currently, there appears that no counties use the data from the designator.
- BIP Work Group
 - Scott Hyde is a part of this Committee now and is wanting FVSN to be a part of it.
- Update Charter
 - Names in Charter
- DV Standard Conditions
 - Create a uniform package to send to OACCD in hopes they can get it to the legislator
 - Bring in conditions to next FVSN meeting. Send them to Megan Bubar at megan.bubar@columbiacountyor.gov
 - Discussion on when to allow Victim Contact
 - Gradual reunification process
 - Must be engaged with treatment.
 - Getting treatment input
 - Include Polygraph condition.
 - Mutual desire for contact, possibly using Victim Advocate
 - PO discretion based off assessments and treatment.
 - Possibly some form of a Lethality Assessment
