- Have secured a keynote speaker for DV week but still waiting for OACCD approval for cost
- o Legislation is looking at language regarding sentencing for DV offenders
- Legislation possibly going to combine all grants regarding specialty courts, jail programs, and possibly DV supervision
- Unsure of Federal funding and possible cuts

Training

 - DV survey regarding DV offenders and DV treatment providers
 - For advisory committee for attorney generals office
 - Viewing evidence based approaches to re-write OAR
 - Encourage others to take the survey
- Sgt. Reddington Peer Team
 - Peer Team created of people in our line of work
 - Talking with peer support team is protected under ORS
 - Peer Support uses open expression and is confidential
 - Not for therapy but for conversations and can offer assistances through additional resources

- Can have conversations regarding things at work and/or struggles in your personal life
- Goal is to keep staff healthy and mentally engaged
- Kelly Rios Chaplain
 - Protected under confidentiality and is protected for officer involved shootings
 - Shared person story regarding her life in foster care, living through DV as a child from her father

FVSN Initiatives Discussion

- BIP Best Practices
 - o 36-52 weeks long
 - Some county BIPs evaluate at the 18-week mark to decide length of program
 - Everyone in the same groups, regardless of risk level
 - Josephine Co in house program
 - Separates risks
 - Follows OAR
- Jon Hansen and Scott Hyde Best Practice for BIP
 - \circ $\,$ Lane Co has contracted BIP to have a say in treatment $\,$
 - Fully covers BIP for offenders
 - Has BIP follow corrections requirements
 - Hood River pilot program with Innterworks
 - BIP all online
 - 36-40 weeks long
 - Have Probation Judgements read, do DV assessment and follow recommendations, rather than just mandate DVTX
 - Helps BIP if they are sent the ODARA and LS/CMI to help separate risk groups
 - \circ $\;$ Re-writing OAR to hopefully change current BIP practices
 - Veterans are the highest growing population for DV offenses followed by homosexual relationships – national statistics
 - Ideal DV package
 - Wants
 - Treatment in DOC
 - Assessment to properly gauge risk for both supervision and DVTX
 - Have release counselors start conversation regarding no contact prior to release – possible policy *will have further discussion on this
 - State wide DV package
 - o No contact

- o GPS tracking if needed
- Electronic Search condition
- No intimate relationships without prior approval
- Polygraph funding for at least 2 tests while on supervision
- Victim info and photo
- Offer couples counseling towards end of BIP
- Barriers
 - Funding for DV treatment
 - DV treatment not provided in DOC
 - Offenders allowed contact with victim while in DOC
 - LS/CMI is not great to project risk for DV offenders

- Umatilla Co has one new hire in the academy, higher case numbers
- Marion Co not hiring at this time due to budget concerns
- Linn Co one new hire and one in backgrounds
- Polk Co one new hire that graduated academy, hired case aid
- Columbia Co one new hire graduating academy, possibly hiring depending on budgets, jail levy failed will try once more before jail closes, testing pilot program where office is closed Fridays
- Gillum/Wheeler caseload around 35
- Klamath Co not hiring due to budget
- Hood River No updates
- Union Co one PO retired, lack of defense attorney which is delaying court processes, began UCCI classes out of their office
- Deschutes Co two have graduated from the academy, not hiring due to budget
- Curry Co will be hosting next FVSN, in the middle of a levy
- Josephine Co hired one PO, change of DV POs
- Lincoln Co caseloads around 65, lost deputy director,
- Clatsop Co First time attending FVSN
- Tillamook Co Hiring new POs, caseloads around 70
