Training

- Polygraph Training with Mike Tabor
 - Different Types of Polygraph Exams
 - Specific Issue – Single issue exam that address a narrow topic, 90-95% accuracy
 - Multi Issue – Covers two topics that are closely related, 83-88% accuracy
 - Mixed Issue – Covers two or more issues that are not necessarily related, 65-75% accuracy
 - Peak of Tension – Used for hidden info, hidden weapons, missing person, accuracy dependent on issue being tested
 - Limitations of Polygraphs
 - Cannot conduct on pregnant women
 - Cannot conduct on subject with a pace maker
 - Subject must be able to hear
 - Subject with recent cardio issues could be disqualified
 - Subject with history of seizures could be disqualified
 - Subject must be cooperative to complete a successful exam

- Provide Examiner with all known information or concerns of person taking the exam
- FARA – Family, Faith and Relationship Advocates with Robert Miller
 - DV Treatment, Parenting Classes, Mental Health and additional services/wrap around services
 - Focus on Empathy and Emotional Intelligence
 - Provides Reunification Therapy for DV offenders and victims

- Possibly start recruiting for FVSN at DV Academy and hold a FVSN meeting at the DV Academy

 - More hands on/role play of DV scenarios

 - Update DV 101 slide show with more recent data, ie DV Misd. Cases and verbiage overall
 - Include Megan Beckner's email to resources to sign up for FVSN and OACCD Link
